3. 'File code' of the Memorandum of Understanding

The University of Patras and Russian-Armenian University, wishing to promote co-operation between the two institutions in education and in academic research, agree to explore:

- a. co-operation on academic programmes;
- b. the development of joint research activities;
- c. and facilitate, university staff exchanges or mutual visits to both institutions;
- d. doctoral student training and development;
- e. student exchange and/or visiting programmes;
- f. the exchange of information, including the results of teaching and research collaboration;
- g. any other activities viewed to be mutually beneficial.

The terms of co-operation for each specific activity implemented under this Memorandum of Understanding (MoU) shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity and will be the subject of separate agreements. In addition, in this Memorandum of Understanding partner organisations mutually accept their respective criteria and procedures for quality assurance, assessment, validation and recognition of knowledge, skills and competence for the purpose of transferring credit.

4. Assessment, documentation, validation and recognition

Any use of the names "University of Patras" or "Russian Armenian University", including any of its constituent schools, departments, programmes or logos, relating in any way to the activities described in this MoU, shall be subject to prior written approval.

The administration of this MoU will be the responsibility of the Department of International Affairs of the University of Patras and the Russian Armenian University.
